**TERMS & CONDITIONS**

1. The promoters are Warshay Investments Pty (Ltd) Reg no 2012/018 792/07 ta KWV (“KWV”)
2. This promotional competition is open to all South African residents within the borders of South Africa, who are 18 years or older at the date of entry, in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoters, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
3. This promotional competition commences on 26 April 2021 and ends on 30 June 2021. Any entries received after the closing date will not be considered.
4. To enter, participants will be required to:
  - a. Buy 1 x 750ml bottles of KWV 3 year old brandy or KWV 5 year old brandy from a participating store.
  - b. Dial \*120\*1608#, follow the prompts and enter your unique code found on the inside of promotional neck tag on pack, to complete entry
