

Warshay Investments (Pty) Ltd T/A KWV and Liquor City Barrel Fridge competition.

TERMS & CONDITIONS

1. The promoters are Warshay Investments Pty (Ltd) Reg no 2012/018 792/07 ta KWV (“KWV”) and Liquor City - The Liquor Boys CC, located at 2 Burg Street, Boksburg, Gauteng 1459 South Africa ta (“Liquor City”) the Promoters.
2.
