

Warshay Investments (Pty) Ltd T/A KWV Win a Case of Ponchos Competition.

TERMS & CONDITIONS

1. The promoter is Warshay Investments Pty (Ltd) Reg no 2012/018 792/07 ta KWV (“KWV”) (“the Promotor”)
2.
