TERMS & CONDITIONS

2. This promotional competition commences on 04 October 2021 and ends on 30 November 2021. Any entries received after the closing date will not be considered.

4. Participants may enter as many times as they wish provided that each entry is associated with a separate purchase and unique transaction.
